

## FROM THE BOARDROOM



At the October 12, board meeting, Northfield I & II Board of Directors (BOD) voted unanimously to keep the 2016 Homeowner Assessments at \$450.00. This decision was due in part to the high percentage of homeowners who paid their annual assessments in a timely matter.

The Northfield I & II BOD approved to purchase new playground equipment at a cost of \$25,000.00. The price includes removing the old playground equipment and the installation of a new play system.

Northfield I & II BOD approved a 2016 security subcontract with West Bellfort POA for Constable Patrol. This contract will remain at the same rate as 2015. The current cost of constable security is \$53,000.00.

#### YES, PHOTO ID IS STILL IN EFFECT!!!!

The Texas Election Code, Title Chapter 63, provides that a voter is required to present one of seven forms of **PHOTO** identification at the poll before the voter is permitted to cast a regular ballot. The seven types are listed below:

- Texas driver license -unexpired or expired less than 60 days
- Election Identification Certificate (EIC)
- Texas identification card- unexpired or expired less than 60 days
- Texas concealed handgun license-unexpired or expired less than 60 days
- U.S. passport- unexpired or expired less than 60 days
- U.S. military identification with photo
- U.S. citizenship certificate with photo

Election Day, November 3, 2015 is drawing near and in Texas an individual must vote at the voting location for the precinct in which he or she is registered to vote and has been designated to vote. In Precinct 525, A.A. Milne Elementary School is the current polling location for those who plan to vote on Election Day.

Special modifications are made for the disabled or individuals who are physically unable to enter the polling location. Just notify the presiding precinct election official that someone needs to vote outside and a voting machine will be brought to the curb.


#### **FYI.....**

## **2015 Ballot Propositions**

## State of Texas Constitutional Amendment Election

## **Proposition 1:**

Right now, a homeowner does not pay property taxes on the first \$15,000 of a home's value. Are you in favor of increasing this exemption to the first \$25,000 of a home's value?

## **Proposition 2:**

Currently, fully disabled veterans do not pay property taxes on his or her home, but if the veteran passes away, there are questions whether the tax exemption can transfer to the veteran's surviving spouse. Do you support clarifying the law to ensure that the homeowner property tax exemption transfers to the surviving spouse of a deceased, fully disabled veteran?

## **Proposition 3:**

This amendment would allow a statewide elected official (Agriculture Commissioner, Land Commissioner, Comptroller, etc.) to live away from Austin. Do you think a statewide elected official should be able to live away from the state capital?

## **Proposition 4:**

Should charities associated with professional sports teams be allowed to conduct raffles for charity?

## **Proposition 5:**

Currently, counties with populations under 5,000 can construct and maintain private roads as long as the property owners pay for the services. Are you in favor of increasing this ability to counties with populations of 7,500 or less?

## **Proposition 6:**

Should the Texas Constitution recognize the right of people to hunt and fish while following laws promoting wildlife conservation?

### **Proposition 7:**

Should Texas commit an extra portion of already existing sales tax and vehicle tax collections to fund non-tolled roads after first funding other essential state services?

## 2015 Ballot Propositions (cont.)

## **Harris County Proposition Election**

**Proposition 1:** 

Do you support a Harris County tax increase to fund \$700 million in Harris County Road Improvement Bonds, which include \$60 million for neighborhood street replacement and repair?

**Proposition 2:** 

Do you support a Harris County tax increase to fund \$60 million in bonds for county parks?

**Proposition 3:** 

Do you support a Harris County tax increase to fund \$24 million in bonds for a county veterinary and public health center?

**Proposition 4:** 

Do you support a Harris County tax increase to fund \$64 million in bonds for improved flood control?

## **City of Houston Proposition Election**

**Proposition 1:** 

Currently, an individual may not be discriminated against in Houston based on sex, race, color, ethnicity, national origin, age, religion, disability, pregnancy, genetic information, military status, familial status, or marital status. Are you in favor of the Houston Equal Rights Ordinance (HERO) that adds sexual orientation and gender identity to the list of factors the city or a company may not use to discriminate?

**Proposition 2:** 

After being elected, Houston officials, such as the mayor, currently serve for two years before seeking re-election, and they are limited to only three terms (total of 6 years). Do you support increasing the time between elections to four years and limiting the official to only two terms (total of 8 years)?

## 84<sup>TH</sup> TEXAS LEGISLATIVE SESSION SUMMARY

The 84<sup>th</sup> Texas Legislative Session began January 13 and ended on June 1, 2015. Collectively, the House and Senate filed over 6,000 bills. Only about 1,000 bills filed actually passed. 111 of the bills that passed affect public education.

The most prevalent legislative issues included reducing student testing, improving accountability, turning around underperforming schools, and improving post-secondary readiness.

The legislature also passed truancy reform, which makes failure to attend school a civil offense instead of a criminal penalty.

Regarding funding, the legislature only added \$1.5 billion for enrollment growth to public education over the 2016-17 biennium. This upset school leaders because most were hoping at least for \$2.2 billion.

The House was willing to increase public education funding by \$2.2 billion and they set aside an additional \$800 million if the school finance bill passed (HB 1759).

The House did not pass school finance, so the budget negotiators used the Senate's number. The Senate was a much more conservative body and only wished to spend an additional \$1.5 billion. Moreover, this means school systems statewide will continue doing more with less state funding.

In Houston ISD, local taxpayers fund over 90 percent of the district's budget. The state only covers a fraction of our annual expenditures.

#### **HISD PRIORITY: CHAPTER 41**

According to Chapter 41 of the Texas Education Code, Houston ISD is a "property wealthy" district, even though over 80 percent of our students are economically disadvantaged.

The Chapter 41 law requires property wealthy districts to write a check containing local taxpayer dollars to the state. In turn, the state uses those local dollars to fund "property poor" school districts elsewhere.

The small \$1.5 billion increase from the state means HISD must write a check to the state both years of the 2016-17 biennium.

Before session, our check to the state could have exceeded \$200 million. However, our legislative efforts were able to get the payment reduced. Current estimates show HISD will have to write a total check of \$140 million to the state.

#### **HISD PRIORITY: PRE-K**

Securing additional dollars for Pre-K was another legislative accomplishment this session. With early education as Governor Abbot's top priority, the legislature provided modest funding for Pre-K and teacher training academies this session.

The legislature appropriated \$40.6 million for math and reading teacher academies to equip teachers with stronger teaching skills.

The legislature also appropriated \$118 million to fund high quality half and full day Pre-K programs.

HISD should see increased funding for our full-day Pre-Kindergarten program during the 2016-17 school year. HISD supported the governor's early education plan.

#### **HISD PRIORITY: DUAL CREDIT**

Another key accomplishment for HISD this session was dual credit. High school students in HISD needed more access to college-level coursework.

With the passage of HB 5 in 2013, school districts received increased flexibility to work with the business community, colleges and universities. However, state law only allowed us to work with one community college – HCC.

HISD passed Senate Bill 1004, a bill that allows school districts in Harris County to work with the four community colleges in the county: HCC, Lone Star, San Jacinto and Lee College.
